

Privacy Policy

Cherishedcockers.org has adopted this Privacy Policy in order to inform you of its policies with respect to information collected from this website. Your visit to Cherishedcockers.org is subject to this Privacy Policy and our Terms and Conditions. Please note that this Privacy Policy governs only information provided to Cherishedcockers.org and communications from Cherishedcockers.org. It does not govern any other information or communications that may reference Cherishedcockers.org. Non-Personal Identifiable Information
